#### WHAT IS A DISPENSING FEE?

The dispensing fee is a fee that pharmacists can add to the price of the medicine when they dispense it to the buyer(1). This fee has been set by the South African Pharmacy Council (SAPC). Government introduced a Single Exit Price (SEP) for all medicines which intended that the manufacturers set the price of medicines. This meant that the pharmacies could not add a profit to the medicines, so the dispensing fee was introduced to make up for this. The dispensing process involves the pharmacist applying professional skills such as analysing the prescription for any problems, counselling the patient with information on the correct use of the medicines, side effects, and providing advice, where needed, on any lifestyle modifications or precautions.

### WHAT IS A PROFESSIONAL FEE?

The professional fee is a fee that a pharmacist may charge for specific pharmaceutical services(2.) The professional fees which pharmacists may charge have been determined by SAPC and should be the same for a specific service at any pharmacy that offers professional pharmaceutical services.

### WHAT IS A PROFESSIONAL PHARMACEUTICAL SERVICE?

A professional pharmaceutical service is a service that has been approved by the SAPC, for pharmacists to carry out. These services include monitoring of blood pressure, cholesterol, blood sugar levels, family planning services, healthy lifestyles advise, etc. The pharmacist should be correctly trained and qualified before they are allowed to carry out the service.
