

The Smell of Apples and Missing persons could be seen to constitute the spectrum of white male identity in South Africa - the first in terms of depicting the consistency of Apartheid ideology in perpetuating itself, the latter in terms of illustrating the discontinuities and fractures within the ideology in sustaining itself - highlighting Foucault's idea that power is never absolute.
