# **DIRECTOR'S MESSAGE:**PROF. DUGAN FRASER

t is easy to imagine that the human condition is getting worse. Climate change, inequality, growing intolerance ... And yet, in many ways things have never been better for our species, especially for those of us who are African: life expectancy is the longest it's ever been, child mortality is at an all-time low and extreme poverty has been rolled back in ways that seemed unimaginable 50 years ago. Still, we do face extinction-level challenges. Principally, rising temperatures caused by human activity threaten our ability to feed future generations and sustain our lifestyles, and we really don't know what our environments will look like or how we will respond. Successfully navigating our way into the future requires: a shared sense of the results that matter, useful evidence of what's actually being achieved, and clear plans for how to do better. Exactly what good monitoring and evaluation can provide.

Good monitoring and evaluation can help humanity successfully navigate its way through stubborn paradoxes and mounting uncertainty. Effective M&E must be done in "joined-up" systems. Disparate, disconnected processes in planning, implementation, reporting and evaluation cannot deliver the insights and analysis we need to manage complexity and operate with agility, especially in the confusing, cacophonous world we have created. For CLEAR-Anglophone Africa, 2019 was the year in which we made a very intentional decision to shift to a more systemic approach to our work.

Robust, effective, country-owned M&E systems are at the heart of CLEAR-AA's M&E capacity-strengthening work. Building on our previous work, CLEAR-AA's focus going forward is on country-owned and country-led strategies to improve M&E. Our new practical regionalisation strategy will see us facilitating and supporting a cohort of English-speaking countries to design, build and implement their own unique M&E systems.

CLEAR-AA's important strategic shift happened under Dr Laila Smith CLEAR-AA's director for the last five action-packed years. Her leadership has built CLEAR-AA into a strong, effective institution with a reputation across English-speaking Africa for professionalism and excellence, driven as always by CLEAR-AA's hardworking and inspiring staff.

We wish to thank Dr Smith for the significant achievements by the centre under her leadership. Professor Fraser has led a process to revise and refresh CLEAR-AA's strategic vision. The new strategy is driven by an effort to formulate and implement country programmes based on collaborative partnerships with a range of stakeholders, and is consistent with the faculty's overarching approach: to achieve collective impact through collaboration.

CLEAR-AA's key strategy is to work in partnership with individuals, institutions and governments. We see this as the key practice for navigating complexity in the 21st century. An important element of CLEAR-AA's new strategy is the creation of its Research and Learning business line, which aims to generate insights into the field of evaluation capacity development and to build a community of practice both inside and beyond the university. In September 2019, I was pleased to participate in CLEAR-AA's Learning from Performance Review, undertaken by the World Bank's Independent Evaluation Group, where I was impressed by CLEAR-AA's performance and the passion of its staff.

The support of the Independent Evaluation Group is a key factor in the success of CLEAR-AA. A range of other donors, particularly the Swedish International Development Cooperation Agency, have also been important contributors to CLEAR-AA's program. I wish to express the university's gratitude to CLEAR-AA's donors for their support. We are all looking forward to seeing more of CLEAR-AA's great outputs in years to come.



#### **EVALUATION SYSTEMS**

## Improving M&E performance by developing and strengthening national M&E systems

CLEAR-AA's consultative approach means that we work with the custodians of a country's M&E system: government ministries and agencies doing M&E work, civil society organisations and Voluntary Organisations for Professional Evaluation. Stakeholder participation ensures that our in-country partnership programmes are country owned, and local expertise ensures that they are context specific.

#### 2019 highlights

#### Active development partners

In 2019, CLEAR-AA supported civil society organisations working with the Ministry of Health in Uganda and the Ministry of Water and Sanitation in Ghana to become active development partners in government planning processes and M&E systems.

#### In-country partnerships

We initiated in-country partnerships in Tanzania, Uganda, Liberia, Zambia, Lesotho, Kenya and Sierra Leone. In Liberia and Sierra Leone, the programmes are managed and implemented by the Ghana Institute of Management and Public Administration (GIMPA), while CLEAR-AA provides technical backstopping.

#### Collaboration and engagement

Government and non-state development actors tend to work in isolation from each other despite having common development goals. In 2019, CLEAR-AA partnered with Twende Mbele to diagnose and improve collaboration and engagement between civil society organisations and governments.

#### A new M&E situation analysis tool

Our succinct compilation of situation analysis reports on Zambia, Uganda, Ghana, Kenya and Rwanda provide a basis for understanding and strengthening these countries' M&E systems. CLEAR-AA's has developed a Monitoring & Evaluation Situation Analysis (MESA) tool to do these situation analyses.

#### STRENGTHENING LEGISLATURES

### Improving evidence use and M&E processes to support effective decision-making in parliaments

CLEAR-AA's approach to strengthening legislatures across East. Southern and West Africa is based on collaborating with representatives from parliaments and organisations working to support them. CLEAR-AA has collaborated with the African Parliamentarians' Network on Development Evaluation (APNODE) since 2016, and is represented on its executive committee. We learn from and complement our partners.

#### 2019 highlights

#### Turning our experience into a resource

At a planning and conceptualisation workshop in Nairobi in October 2019, representatives from parliaments and partner organisations declared their interest in authoring various chapters for a book that will document what we're learning and offer it as a resource.

Informal communities of practice through online forums have become rich spaces for sharing learning and resources and for exploring collaborations.

#### Exploiting digital technology to power parliamentary oversight

The African Parliamentary Oversight Tool is being developed as a workflow-supporting app for parliamentarians and parliamentary staff to manage how they find, access and use information to make decisions. A participatory piloting workshop was held in Nairobi in June, with representatives from 10 parliaments and the African Parliamentarians' Network on Development Evaluation.

#### Navigating the politics of evidence use

One of our challenges is supporting parliamentarians and parliamentary staff to navigate the competing interests in evidence use in the complex, dynamic, political institutions that parliaments are. Working closely with parliamentary representatives themselves is a particularly valuable way to explore how evidence use in parliaments can be strengthened.

CLEAR-AA's wide-ranging collaborative work is delivering a trailblazing body of knowledge on systems of evidence use in African parliaments.



#### CAPACITY STRENGTHENING

Strengthening individual and organisational capacity to plan, use, do and manage M&E

#### 2019 highlights

#### Context-driven, practice-based M&E training for Africa

Thirty-five participants from thirteen countries benefitted from CLEAR-AA's annual two-week Development Evaluation Training Programme in Africa (DETPA) in September 2019, now in its third year.

#### Global M&E training

CLEAR-AA partnered with the International Programme for Development Evaluation Training (IPDET) to support their agenda of ensuring inclusivity and contextual relevance to regions such as Africa. CLEAR-AA co-delivered three of the core course modules, and our associates facilitated a specialised workshop on building national evaluation systems. We also facilitated the Programme in Rural M&E (PrIME), a high quality, global and sustainable training programme in M&E for rural development professionals, to a cohort of international practitioners, in partnership with CLEAR Latin America and the Caribbean (CLEAR-LAC) and the International Fund for Agricultural Development (IFAD).

#### M&E curriculum development experts

CLEAR-AA presented the M&E competencies curriculum, developed collaboratively with universities across Africa, to a number of conferences, including the 9th African Evaluation Association conference in Abidjan, Côte d'Ivoire. We are working with universities in Uganda and South Africa on possibly piloting the curriculum. In addition, we reached an agreement with the Chair in African Philanthropy at the Wits Business School to begin developing Africa's first Master's programme in Impact Management.

CLEAR-AA continues to develop a growing compendium of high-quality courses that can be tailored to meet the M&E capacity-building demands of a variety of clients. In 2019, we refined and packaged our more popular courses: M&E Planning and Management, and Theory of Change.

In 2019, we secured more than ten scholarships for training events through our partnerships with organisations like Twende Mbele, 3ie and the World Food Programme, building on previous years' commitments. Expanding these commitments can ensure greater access to high quality M&E capacity building opportunities in Africa. CLEAR-AA's offerings cannot be limited to those with financial resources, but must be accessible across Africa.



#### **TECHNICAL ADVISORY**

Assisting governments and private institutions to strengthen institutional systems of evidence while driving organisational change towards a culture of evidence use

CLEAR-AA has become a key player in skills development in South Africa.

#### RESEARCH AND LEARNING

#### Driving CLEAR-AA's research agenda

CLEAR-AA established our Research and Learning business line in late 2019 to drive CLEAR-AA's research agenda, previously under the Strategic Knowledge Management and Research unit. Research and Learning's work cuts across all the other business lines, and is designed to enable CLEAR-AA staff to improve their performance and share knowledge with other stakeholders. Our first study looked at M&E system capacity-strengthening in eight African countries.

#### Lessons for M&E system capacity-strengthening from eight African countries

- In resource-constrained countries, strengthening the evaluation skills of performance monitoring staff will contribute to addressing the M&E skills shortage and foster a culture of using evidence in decision-making at the implementation level.
- M&E system capacity-strengthening needs are not homogenous, hence the need for an inclusive needs assessment.
- The design of capacity-strengthening approaches needs to factor in the country context. An M&E system's functionality depends on the context in which it is operating. Organisational culture and norms are nuanced by local context.
- Technical support and financial resources are required to develop functional and effective M&E systems.

CLEAR-AA's research and learning studies provide practice guidance to individuals and organisations working in the M&E capacity-strengthening space in Africa.
